## Fees and Payments

Lakeside is approved and licensed by the State of New York for both the Medicare and Medicaid Programs. The facility also cooperates with the Veterans Administration to provide nursing home services to VA beneficiaries. Lakeside works directly with Medicare, Medicaid, the VA and many private insurance companies regarding the reimbursement for services provided to beneficiaries of these programs. Lakeside's Business Office will assist each resident or their responsible party in working with you and your payer sources

### What is the Basic Room Rate?

Private Room \$215./day  
Semi-private \$205/day

### Do I Pay Anything in Advance?

If a resident is qualified for Medicare or Veterans Administration coverage upon admission to Lakeside, no pre-payment is necessary. If a resident is covered under Medicaid, the resident is required to pay Lakeside, upon admission, the first month's NAMI amount (Net Available Monthly Income, which is the resident's personal contribution to room and board as determined by the Department of Social Services). If the resident is not covered by any of the above programs, a deposit is required, covering the first 30 days payment at the daily basic rate.

### What's A Personal Account?

Lakeside's Business Office can help you set up a personal account to which you can make deposits to cover incidental expenses such as hair cuts, newspaper, phone and cable charges.

### What Does the Basic Room Rate Cover?

The Admission Agreement lists and defines all services included in the Basic Room Rate. The Admission Agreement is signed by the resident or responsible party on the day of admission. Lakeside and the resident each retain a copy of the Agreement. Below is a brief summary of the services that are covered in the basic room rate:

- 24-hour nursing care
- Use of routine medical supplies and equipment
- Meals with special diet care and dietitian services
- Social Services
- Recreational Programs
- Religious Services
- Laundry Services for washable personal clothing
- Fresh bed linens
- Housekeeping
- Assistance and/or supervision, as needed, for activities of daily living (toileting, bathing, feeding, help with walking)

### Other Services Provided but Not Included in the Basic Room Rate!

Fees for services provided but not included in the Basic Room Rate are paid by a third party such as Medicaid, Medicare or an insurance company or by the resident directly. A complete listing and explanation of how such services are billed and paid is covered in the Admission Agreement. A brief summary of the services which are provided but are not covered in the Basic Room Rate can be found on the next page.
